ENGAGEMENT PROGRESS

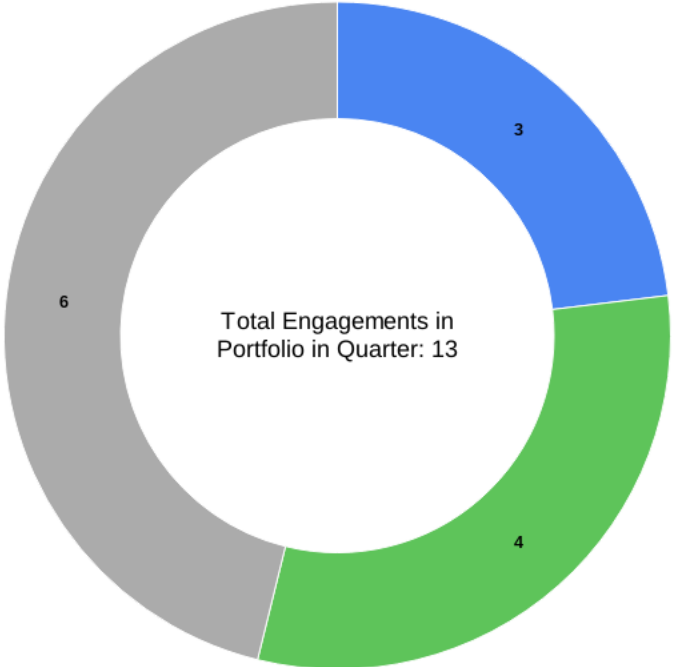

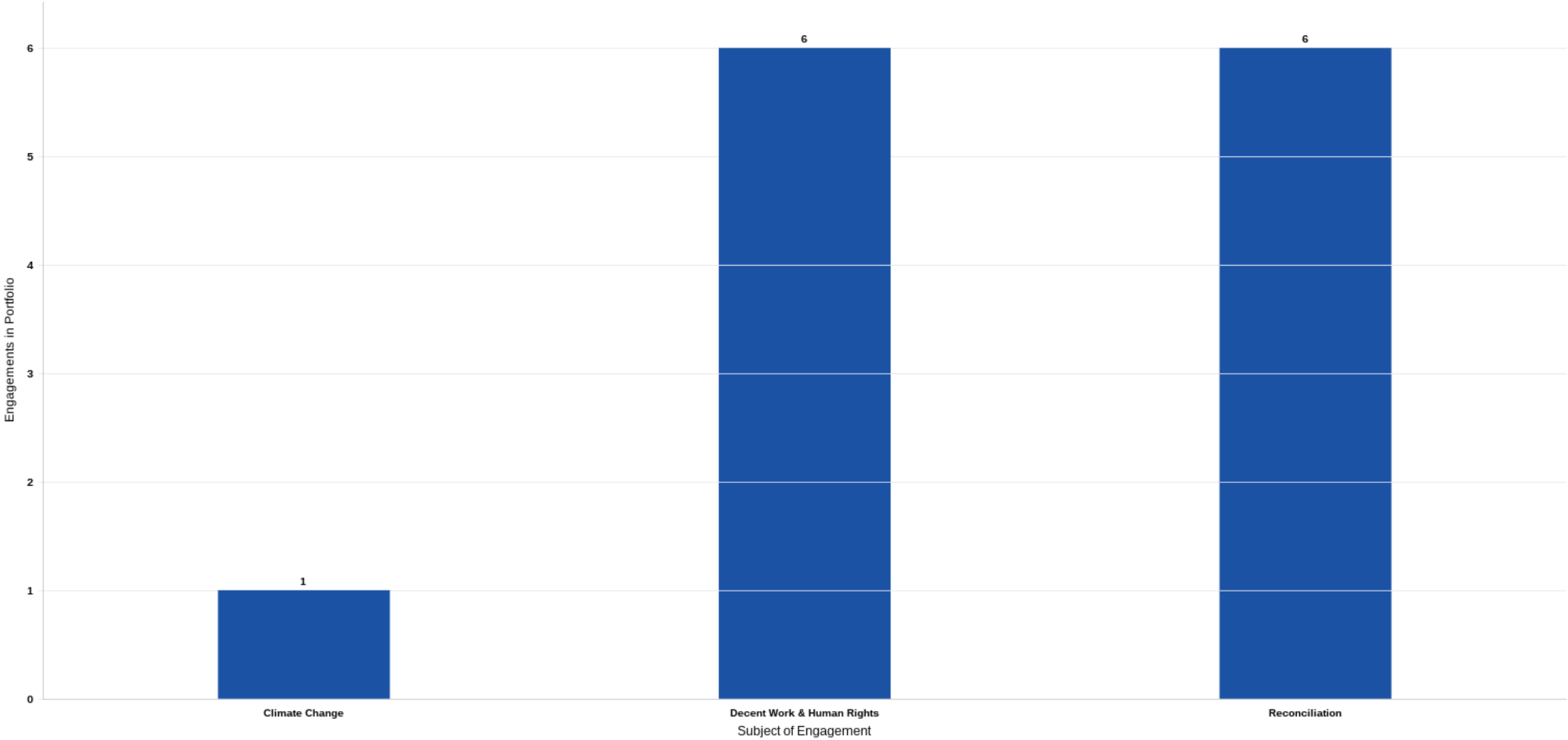
